

Ogemaw County Board of Commissioners 2024 Meeting Schedule

Unless otherwise changed by the Board, regular meetings of the Board of Commissioners shall be held on the second Thursday of each month and on the fourth Thursday of each month. The meeting held on the second Thursday of October shall be designated as the Annual Meeting as required by law (MCL 46.1[1]). The Board shall meet on the Tuesday following the second Monday in April each year to equalize the assessment rolls in the manner provided by law (MCL 209.5[1]). If any regular meeting falls on a recognized holiday, the Board will meet on the Tuesday immediately prior to the regularly scheduled Thursday meeting.
