Motion by Neubecker, second by Scott, the Committee of the Whole meeting begin at 8:00 a.m. Additionally, the Commissioners second regular meeting of the month begin at 5:30 p.m. Roll call vote. Ayes – Reetz, Vaughn, Neubecker, David, and Scott. Motion carried. [1-1-#4]

Motion by Reetz, second by Scott, the meeting agenda be approved. Voice vote. Ayes – all. Motion carried. [1-1-#5]

PUBLIC COMMENT:

Dale Sheltrown inquired about a potential lawsuit the County would initiate against Logan Township. He was told Logan Township is paying the E-911 Service Assessment. He also asked what law allowed the Commissioners to levy an E-911 service assessment fee. Chairman Reetz stated the board would research the matter. Commissioner Scott stated the Board assessed the fee based on work done by the E-911 Advisory Board.

Mischelle Warner, MSU Extension District 4 Coordinator, introduced herself and distributed program updates to board members

Al Evans suggested new commissioners provide a brief bio for meeting attendees. Commissioners Vaughn, Neubecker and David each provided personal background information to the meeting attendees.

County Clerk Klacking updated the board on various items.

Mandi Chasey, Ogemaw County EDC Agent updated the board on various matters.

Commissioner Vaughn attended Cumming Township meeting. He stated an individual is planning on sponsoring an arts and music festival June 5 - 10, 2019 in the township.

Commissioner Neubecker attended Churchill and Mills Township board meetings. The township is seeking a new township attorney. They are also concerned about property splits. Mills Township is concerned about a Road Commission board member having access to the Road Commission health insurance. Mills Township did vote to pay the County E-911 Service Assessment.

Commissioner David attended Logan and Richland Township meetings. Logan did vote to pay the E-911 Service Assessment. The question has arisen if the Road Commission representation can be by districts.

Commissioner Scott attended Foster and Ogemaw Township meetings. All is well. He welcomed the new county commissioners and stated he is ready to assist them as needed.

Chairman Reetz attended West Branch Township and City of West Branch meetings.
